A specialist best online casinos for us players political external who has worked for the CIA and the National Security Council of the House of Representatives (NSC) was indicted for accusations from the USA, she worked as an unregistered agent of the South Korean government.

Sue Mi Terry defended South Korean political positions, divulged non-public information from the USA government to intelligence officials of South Korea and facilitated access to South Korean government authorities to her counterparts in North America.

In exchange, South Korean intelligence officials supposedly provided Terry with Bottega Veneta and Louis Vuitton bags, Dolce & Gabbana; restaurants best online casinos for us players Michelin.

The supposed work of Terry as an agent began best online casinos for us players 2013, two years after she left her job in the USA government and lasted a decade.

She is now a senior policy analyst at the Council on Foreign Relations, according to the site of the think tank and specialist best online casinos for us players East Asia (East Asian) or the Korean Peninsula.

Terry did not respond immediately to a request for comment, but her lawyer Lee Wolosky said best online casinos for us players communicated: "These allegations are unfounded and distort the work of the diligent and independent researcher known for best online casinos for us players independence."

"In fact, she was a harsh critic of the South Korean government during the best online casinos for us players time that this accusation alleged she was acting on her own. One time clarified these facts will be evident the fact of a significant error committed by the Government", he added :

The Council on Foreign Relations placed Terry best online casinos for us players license administrative non-remunerated and will cooperate with any investigation, said a spokesman. South Korea is not a defendant. Her embassy best online casinos for us players Washington did not respond immediately to requests for comment. The USA prosecutor's office in Manhattan did not respond to similar requests without delay.

According to her online biography, Terry is a frequent guest on TV and radio. Born best online casinos for us players Seoul and raised in Virginia, Terry was a senior analyst at the CIA from 2001 to 2008; director of Korean Japan and Oceanic Affairs at the NSC from 2008, under the president of the Republican George W. Bush (democratic president) Barack Obama. She now lives best online casinos for us players New York, says her biography.

The accusation accuses Terry of not registering under the Foreign Agents Registration Act and conspiring to violate this law.

She says she gave best online casinos for us players a voluntary interview to the FBI, in June 2024 that she was a "source" for the South Korean intelligence service - the meaning is a valuable information.
