Elena Rybakina avança às quartas de final do Wimbledon com facilidade

A atual campeã de Wimbledon, Elena Rybakina, disse que não sente pressão enquanto avança na competição deste ano. Ela derrotou Anna Kalinskaya por 6-3, 3-0 antes que a russa desistisse devido a uma lesão no punho. Rybakina enfrentará agora a ucraniana Elina Svitolina nas quartas de final.

Com a lesão de Aryna Sabalenka e as derrotas de Iga Swiatek e Coco Gauff, a campeã Rybakina é agora a favorita para vencer o torneio. Ela parece totalmente despreocupada com essa perspectiva, dizendo que quer apenas se concentrar onabet drops jogar uma partida de cada vez.
