### **Crise abala a primeira união dos trabalhadores da Amazon nos EUA**

A historic vitória sportingbet indicar amigo um depósito da New York City marcou a formação, sportingbet indicar amigo território americano, da primeira união de trabalhadores da Amazon , contudo, a união enfrenta desafios internos, esgotamento financeiro e uma disputa sobre a eleição que pode determinar quem irá liderar o grupo no futuro próximo.

No Staten Island, onde a união ainda não possui um contrato com a Amazon. Membros proeminentes renunciaram silenciosamente ou deixaram o grupo para formar um dissidente laboral, que processou a união sportingbet indicar amigo tribunal federal no verão passado para forçar uma eleição para novos líderes.

Obstáculos da Amazon, que tem resistido aos esforços para chegar à mesa de negociações, apesar da pressão dos reguladores federais de trabalho para fazê-lo.

### **Controvérsia na união**

Disputa entre a National Labor Relations Board e a ALU sobre a suposta influência indevida no resultado da votação de sucesso da união. A Amazon argumenta que o resultado - 2,654 a favor e 2,131 contra - não reflete o que a maioria dos empregados deseja. Por volta de 8,300 pessoas trabalhavam no JFK8 Fulfillment Center durante a votação de abril de 2024.

"Quando a lei permite que a gestão atrasar as negociações por anos e use argumentos legais para atrasar o progresso que os trabalhadores começaram, é apenas um enorme obstáculo", disse Benjamin Sachs, professor de direito do trabalho na Universidade de Harvard.

## **Eleição interna**

Em janeiro, após a formação do grupo dissidente chamado A.L.U. Democratic Reform Caucus, a união concordou com um plano acordado sportingbet indicar amigo tribunal para permitir que os membros da fila classificada votassem sobre se deveriam realizar uma eleição para uma chapa de novos oficiais. Durante cinco dias que terminaram sportingbet indicar amigo início de março, mesas com cédulas foram instaladas do lado de fora das portas do enorme depósito da Staten Island. Smalls e outros líderes sindicais fizeram campanha contra a eleição, mas o voto não seguiu o seu caminho.

Nas documentos do tribunal, Arthur Schwartz, advogado que representa o caucus dissidente, disse que dos aproximadamente 350 membros da união que votaram, 60% preferiram ter uma eleição de oficiais sportingbet indicar amigo junho ou julho.

## **Impasse jurídico e lutas internas**

O referendo, que teve uma taxa de comparecimento baixa, não resolveu o impasse jurídico e as lutas internas. Na semana passada, Jeanne Mirer, advogada da união, arguiu em python um documento jurídico que o tribunal federal de Nova York deveria reabrir o plano acordado sportingbet indicar amigo tribunal. Ela o chamou de "defeituoso" e argumentou que violou a constituição da união.

De acordo com Mirer, o documento interno atual da ALU exige que os membros aprovelem uma emenda ou organizem uma convenção constitucional se quiserem realizar uma eleição de oficiais antes de um acordo coletivo de negociação ser negociado com a Amazon. Atualmente, os líderes também argumentam que a união esgotou o seu dinheiro, o que dificulta realizar uma eleição.

## **" Trabalhando um contra o outro não vai ajudar "**

"Isso não importa quem esteja na cadeira", disse Mirer durante uma entrevista. "Qualquer líder tem que trazer a Amazon à mesa, e lutar uns contra os outros não vai ajudar".
